

Feed Purina **HEIFER MAX 21% LAS** coarse or pelleted ration to heifers three to 24 months of age, at a rate of 2 to 2.5 kg. per head per day depending on hay quality.

Feed at the rate of 2 kg/head/day to provide 200 mg. of Lasalocid Sodium.

Do not feed to lactating dairy cows.

Do not feed to sheep due to possible copper toxicity.

Do not feed to off tag species. Do not allow dogs, horses, or other equines or guinea fowl access to formulations containing Lasalocid. Ingestion of Lasalocid by these species has been fatal.

OPTIMIZE YOUR HEIFER RATION


Clarence Farm Services Ltd. recommends you follow these management practices:

1. Provide a source of clean, fresh water at all times.
2. For most forage programs, provide the appropriate Purina dairy mineral free-choice. Minerals should be provided in sheltered feeders.
3. When changing forages for heifer rations, the change should be made gradually by mixing the new ration with the old ration for a period of one week.
4. Consult your veterinarian for recommended herd health program.
