- C) Sheep mineral block should be fed in combination with a grain ration, when pasture quality is average to poor.

CONFINEMENT

Have one 25 kg block available for 15 to 25 animals.

With an average consumption of **Sheep Mineral Block ABF** at 30 g/head/day, supplementation of other minerals (e.g. salt) is not required.

Do not offer this block to animals other than sheep and goats.

Directions for use must be carefully followed.

Feed is perishable. Store in a dry well ventilated area protected from rodents and insects. Do not feed moldy or insect-infested feed to animals as it may cause illness, abortion or death.

Sheep should be vaccinated against enterotoxaemia.
