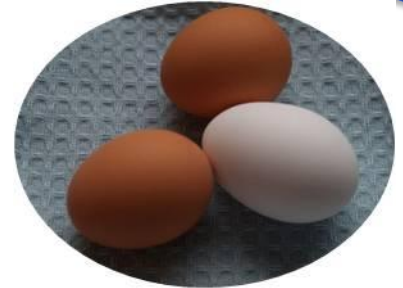

Mix Purina ACCU-CHICKEN BLEND as follows:

Chick starter (0-6 weeks) : 300 kg. supplement with 700 kg. ground grains.
Chick grower (6-18 weeks): 235 kg. supplement with 5 kg. calcium and 760 kg. ground grains.
Layer rations: 275 kg. supplement with 77 kg. calcium and 648 kg. ground grain.
Corn and wheat are preferred grains.



CAUTION:

Do not feed to off tag species including sheep, deer, or other ruminants.

4. Consult your veterinarian for recommended flock health program.
5. Directions for use must be followed carefully.
6. Do not feed this feed in association with another grain ration, supplement or premix containing selenium.
7. Feed is perishable. Store in a dry, well ventilated area protected from rodents and insects. Do not feed mouldy or insect-infested feed to animals or it may cause illness, abortion, or death.

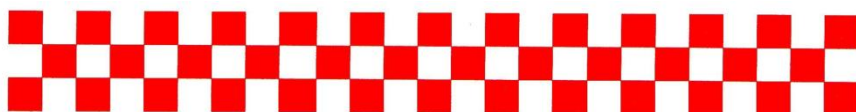
