

Feed Purina **AMP-PURINATURE START & GROW** as follows:

Feed **AMP-PURINATURE START & GROW ABF** on a free choice basis to chicks up to 28 days for broilers and up to 42 days for pullets. **Do not feed to laying birds in production.**

Starting and caring for chicks & pullets:

1. Clean, disinfect and dry the brooding area prior to birds arrival.
2. The brooding area should be a round enclosure, allow .25 square meters per 10 birds.
3. Fill the enclosure and surrounding area with 5-10 cm. of fresh bedding.
4. Warm the brooding area to 32 C. using a brooder lamp.
5. Clean fresh water should be available at all times allow 2 cm. trough space per bird.
6. Chicks must have easy access to feed. Provide 5 cm. of feeding space per bird.


Clarence Farm Services Ltd. recommends you follow these management practices:

4. Do not feed this feed in association with another grain ration, supplement or premix containing selenium.
5. Feed is perishable. Store in a dry, well ventilated area protected from rodents and insects. Do not feed mouldy or insect-infested feed to animals or it may cause illness, abortion, or death.
