
## Calf Growing Ration

# DEC-CALF GROWENA Code 1060

Feed Purina **DEC-CALF GROWENA** coarse as a complete ration to calves from 2 to 6 months of age as follows:

2-3 months	Free Choice
3-4 months	3.0 kg. per calf/day
5-6 months	2.5 kg. per calf/day



## WARNING:

No withdrawal period is required when this medicated feed is fed at recommended rate of 0.5 mg Decoquinatate per kg body weight per day.

Do not feed to lactating dairy cattle producing milk for human consumption.

Do not feed to sheep due to possible copper toxicity.



## OPTIMIZE YOUR CALF'S RATION

Clarence Farm Services Ltd. recommends you follow these management practices:

1. Provide a source of clean, fresh water at all times.
2. To ensure freshness, offer only the amount of feed that calves will consume in one day.
3. Feed good quality hay along with **DEC-CALF GROWENA**. Remove unconsumed hay daily and replace with fresh.
4. Proper housing and sanitation are important to help prevent calf diarrhea and pneumonia. Consult your veterinarian for recommended herd health program.
5. When calves are housed in groups after weaning, provide adequate feeding space to assure that all calves can eat at the same time.
6. Do not use this medicated feed for treatment of outbreaks of Coccidiosis.


