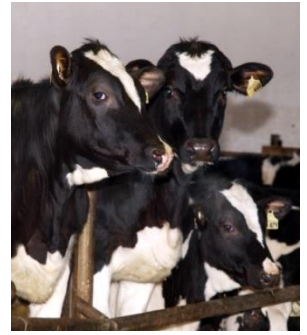

# HEIFERSTRETCHER MS

Code 1105 & 1106

Feed Purina **HEIFERSTRETCHER MS** ration to dairy heifers receiving unrestricted amounts of average quality hay or mixed forages. Feed at the rate of 2 kg/head/day to heifers on pasture over 180 kg body weight to provide 200 mg monensin sodium. Feed 2.2 kg/head/day to heifers consuming 10 kg or 3 kg to heifers consuming 13.6 kg dry matter to provide 22 ppm. of monensin sodium in diet.

NOTE: Medicated with Monensin Sodium as an aid in the prevention of Coccidiosis caused by *Eimeria bovis* and *Eimeria zurnii* in cattle.



Do not supplement Monensin Sodium from other sources, including other feed stuffs containing Monensin Sodium or Rumensin Controlled Release capsule.

Do not feed to sheep due to possible copper toxicity.

Do not feed to off tag species. Do not allow dogs, horses, or other equines or guinea fowl access to formulations containing Monensin Sodium. Indigestion of Monensin Sodium by these species has been fatal.

## OPTIMIZE YOUR HEIFERSTRETCHER RATION

Clarence Farm Services Ltd. recommends you follow these management practices:

1. Provide a source of clean, fresh water at all times.
2. For most forage programs, provide the appropriate Purina dairy mineral free-choice. Minerals should be provided in sheltered feeders.
3. When changing forages or heifer rations, the change should be made gradually by mixing the new ration with the old ration for a period of one week.
4. Consult your veterinarian for recommended herd health program.
