Feed Purina **MILK PERFORMER 40** as a top dress supplement to cows in the first 120 days of lactation.

Increase the feed rate gradually from .5 kg /cow/day immediately after calving to a maximum of 4 kg/day by 32 days (0.5 kg/4 days).

Cows with exceptional genetic capabilities may be fed up to 5 kg/cow/day.

Typical feeding rate is .5 kg /day for cows milking above 25 litres per day.
