

Feed Purina **FRESHEN RIGHT 30% MS** to the far off and close up dry cows. Typical feed rate is 1 kg /cow/day. Mixed grass hay is preferred. If milk fever or other metabolic problems occur consider switching to **CUSTOM ANION PLUS MS** or **CORNERSTONE MS** during the last 2-3 weeks prior to calving.

OPTIMIZE YOUR DRY COW SUPPLEMENT


Clarence Farm Services Ltd. recommends you follow these management practices;
